**SUBJECT: P&I CLUBS ACCEPTED BY TUVALU**

#### **DEFINITIONS:**

The following abbreviations stand for:

- "BUNKER CONVENTION" – International Convention on Civil Liability for Bunker Oil Pollution Damage, 2001
- "CLC92" – International Convention on Civil Liability for Oil Pollution Damage, 1992
- "IG" – International Group of P&I Clubs
- "MLC2006" – Maritime Labour Convention, 2006
- "WRC" – Nairobi International Convention on the Removal of Wrecks, 2007

The term "Administration" shall mean the Tuvalu Ship Registry.

#### **PURPOSE:**

The purpose of this marine circular is to provide a list of P&I clubs accepted by this Administration for the purpose of providing P&I cover as well as for the issuance of Blue Cards relating to the CLC92, BUNKER CONVENTION, WRC, and MLC2006.
