SUBJECT: SANCTIONS AGAINST NORTH KOREA

PURPOSE:

This circular serves to inform all parties of the NK Sanctions Advisory issued by the US OFAC dated 21 March 2019 (appended to this circular) which updates the advisory issued on 23 February 2018. The advisory provides useful information relating to the deceptive shipping practices used by NK to evade US and UN sanctions which exposes parties involved in the shipping industry, such as insurers, flag States, shipping companies, and financial institutions, to significant sanction risks, as well as measures that parties may implement to mitigate such risks.

Note: This updated advisory contains five annexes, three of which are new. The first provides an overview of US and UN sanctions relevant to the shipping industry, including a non-exhaustive list of bases for which persons may be sanctioned by OFAC. The second provides an updated list of 28 North Korean tankers known to be capable of engaging in ship-to-ship transfers of refined petroleum products and other banned goods. The new third annex provides specific guidance for UN Member States and relevant industry actors on best practices to avoid engaging in North Korearelated illicit activities. The new fourth annex provides a list of 18 vessels that are believed to have engaged in illicit ship-to-ship transfers of refined petroleum with North Korean tanker vessels. The new fifth annex provides a list of 49 vessels that are believed to have exported North Korean-origin coal.

IMPLICATION ON TUVALU SHIP REGISTRY AND EXISTING TUVALU FLAGGED VESSELS

Tuvalu is committed to upholding US and UN sanctions against NK and has taken strong measures to mitigate sanction risks, such as carrying out an enhanced screening process for all new registrations, and monitoring of the AIS and LRIT positions of currently flagged vessels. Any vessels found to be suspected of engaging in illicit shipping practices with NK shall have their registrations cancelled without notice.

The vessels and companies list below are restricted from being flagged with Tuvalu and includes vessels listed in Annex 2, Annex 4 and Annex 5 of the NK Sanctions Advisory issued by the US OFAC (reference (a) above) and other vessels and companies which have been deemed to be a sanction risk.
